Ken Partyka – Weed Harvesting - Approximately 627 tons of weeds were removed this year. 2024 was similar to 2023. Plan to look for a new truck for the weed hauling operation.

Pier Permits – 5 permits have been received and reviewed.

Dean Bostrom – Golf Course is up about 576 rounds from last year. Revenues are up this year. Additional irrigation lines are being installed and some tee boxes have been improved.

Mike Cochrane provided financials for the District to date. The tax levy for 2025 tax bills has been filed with the State. Revenues for year seem to all be in. Some expenses are still to be coming. Golf course finances are good. Mike plans to submit to the state for the loan application for the golf course when needed. Currently 6% interest.
